The Building Control (Fees) Regulations, 2020

*(Under section 52 of the Building Control Act, 2013,
Act No. 10 of 2013)*

IN EXERCISE of the powers conferred on the Minister responsible for building works by section 52(2)(f) of the Building Control Act, 2013 and on advice of the National Building Review Board, these Regulations are made this 25th day of August, 2020.

1. Title

These Regulations may be cited as the Building Control (Fees) Regulations, 2020.

2. Fees

The fees specified in the Schedule to these Regulations shall be paid in respect of the matters they relate to under the Building Control Act, 2013 and Schedule 4 of the Building Control Regulations, 2020.
